

# DanceWorks studios...the fine print

**Assumption of Risk:** I / minor's parent / legal guardian, understand the nature of the activities that I / my child will be involved in at Danceworks Studios, and my / the minor's experience and capabilities, and believe the I am / minor to be qualified, in good health, and in proper physical condition to participate in such activities.

**Release of Liability:** I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless each of the releasee from all liability claims, demands, losses, sickness, exposure to COVID, or damages on my own / the minor's account caused or alleged to be caused, in whole or in part by the negligence of the "releasee's" or otherwise, including negligent rescue operations. I further agree that if, despite this release, I, the minor, or anyone on my / the minor's behalf makes a claim against any of the releasee's named above, I will indemnify, save, and hold harmless each of the releasee's from any litigation expenses, attorney fees, loss liability, damage, or any cost that may occur as the result of any such claim.

**Studio/Courtyard Policies:** Parking lot- DO NOT EVER LET YOUR CHILD PLAY IN THE PARKING LOT. We often see parents chatting in the lobby after class while their child walks out the door without them. We also see parents chatting outside the studio while their child plays between cars or in the parking lot. This is absolutely against Courtyard policy. Children are not to be left outside without supervision or leave the building without an adult. Please do not leave children under age 12 unsupervised in Courtyard common areas or restrooms. This is Courtyard Policy. DanceWorks Studios shares the common areas with several businesses. Please respect their students, instructors and equipment. Send your student(s) to the studio prepared for class- Have the student(s) dressed in proper attire, including hair, shoes and props as needed. Before and after class- Most classes start as another class ends. Please gather your child and be prepared to leave the building after class is over. Please be courteous to the class that comes in after your class is over. Communication- The best way to communicate with teachers is via email. Phone messages may not be returned the same day. Teachers cannot accept calls during class time. You can also message us via our Facebook page.

**Payment Policies** - DanceWorks Studios accepts PayPal, Debit/Credit cards and cash.

- ✓ Tuition amounts are for the entire dance year September – May.
- ✓ A registration fee of \$25, per Dance student, is due annually.
- ✓ Tuition is due IN FULL by the first class for students registered in 1 dance class per week.
- ✓ ONLY students or families with MULTIPLE weekly classes may utilize the monthly payment system. You will be invoiced monthly.
- ✓ Tuition for the Dance Year does not include any days we are closed. Payments are divided equally for your convenience. All payments are due at the first of each month. A \$10 late fee will be charged to payments received after the 10th of each month. The late fee is increased to \$15 once Tuition is more than 30 days in arrears.
- ✓ Missed classes should be made up within four weeks of the absence. Classes not made up will be forfeited. Forfeited classes do NOT reduce tuition.
- ✓ DanceWorks Studios has two tuition rates: 1) Full Dance Year and 2) Drop-in rate of \$20 per 60 minute class and \$18 per 45 minute class. If you drop a class, you will be charged whichever rate is least expensive for you.
- ✓ Tuition will not be refunded, rebated, or credit given due to cancellations out of our control.
